Lois is currently enrolled in the long distance Bachelor of Social Work Program through the University of Manitoba. Her past experience includes working in an administrative and financial capacity. Previous to coming to Sagkeeng Child & Family Services in October 2000, Lois was employed for a number of years in the Resource Program at Southeast Child & Family Services. This work took her to the Northern First Nation communities regularly.

Lois is currently employed at Sagkeeng Child & Family Services as a Resource Worker. Through working in the Northern First Nation Communities, Lois' experience has enabled her to work and understand the needs of our First Nation people. She also brings with her a number of administrative skills that enhances her ability to meet the demands and requirements of her position as a Resource Worker.

Elaine Courchene - Finance Assistant

Elaine Courchene is a First Nation member of Sagkeeng and was born and raised in a First Nation community in Saskatchewan. Elaine moved to the community and has resided here since 1995

Elaine has been employed with Sagkeeng Child & Family Services since 1999 as a Financial Assistant. Previous to this Elaine's experience has been primarily in the administrative field. Prior to relocating to the community of Sagkeeng, Elaine was employed as an Administrative Assistant for a large Housing Corporation. Elaine is currently involved in ongoing training in the financial field.

Jennifer Courchene - Administrative Support - Child Abuse Program

Jennifer Courchene is a First Nation member of Sagkeeng. She does not speak the language but does have an understanding of the Objibway language. She was born in Rivers, Manitoba and resided in a small community known as Oo-za-we-kwun until she was school age. Jennifer and her family moved to numerous other towns and communities in Manitoba until they settled in the community of Sagkeeng in 1980.

Jennifer has been employed with Sagkeeng Child & Family Services since April 2000. Initially she was employed as a receptionist, then as a Finance Assistant and recently accepted her present position, Administrative Support for the Child Abuse Program.

Debra Bunn – File Clerk

Debra Bunn is from Fort Alexander Indian Reserve and has been employed with Sagkeeng Child and Family Services for the past three years as file clerk. She is a graduate of Fort Alexander High School and Assiniboine Community College, Grade X11, Community Social Development Worker and Aboriginal Community Development Diploma Program. Besides working at Sagkeeng Child & Family Services, Debbie has also worked for Sagkeeng First Nation in the Social and Economic Development Programs.

It has always been Debbie's goal to work and help the community members of Sagkeeng. As a proud member of Sagkeeng, she is confident that together we can overcome the current difficulties and strive for success in being a First Nation community.

Sandra Bunn – Receptionist (Interim)

Sandra Bunn is a member of Sagkeeng First Nation and with the exception of twelve years in which she lived in Winnipeg, she has resided on the North Shore of the community.

Sandra is a graduate of Sagkeeng Anicinabe High School, and historically one of the first recipients of a diploma from the on-reserve High School. Prior to this the community could only offer a grade eight education to their children. Sandra continued her education at Red River Community College, completing her first year of Business Administration. Sandra remained in Winnipeg and worked in an Administrative capacity for eight years. Throughout those eight years, she continued her education, with the support of her employer, and completed a number of courses at the University of British Columbia.

Sandra is currently employed as the Receptionist in an interim position at Sagkeeng Child & Family Services. Sandra has been actively involved as a community member, volunteering at the school and community level as well as participating as a board member for the local Health Centre.

Crissy Courchene - Receptionist

Crissy Courchene is from Sagkeeng First Nation. She was born in Winnipeg and raised in Fort Alexander Indian Reserve. Crissy has been employed, on an interim basis, as clerical support for Sagkeeng Child & Family Services.

Crissy graduated high school in June 1998 from Sagkeeng Anicinabe High School. She then went on to complete her Business Administration Studies at Red River Community College. Crissy is enrolled in the fall session of the Bachelor of Commerce Program at the University of Manitoba and will be working towards obtaining her degree.

Linda Bunn was born in Lone Island, Manitoba and was raised in Fort Alexander Indian Reserve where she is a band member. Linda is from a family of thirteen born to the late Mr & Mrs Frank Bunn. She also has four children of her own and speaks fluently in both Ojibway and English.

Linda's education includes a certificate in Early Childhood Education. Linda is presently employed with Sagkeeng Child and Family Services as a janitor/custodian since March 1999. Previous to this she was employed with various organizations in the community.

Charles Bruyere - Maintenance

Charles Bruyere is a member of the Sagkeeng First Nation community. Charles was born in Pine Falls and was raised in the community of Sagkeeng until his late teens. He later returned to Sagkeeng in 1996.

Charles entered a two-year program at New Careers in Winnipeg and obtained a certificate in Substance Abuse Counselling. Following his graduation, he was employed at the St Norbert Youth Program for a period of time and then at the Sagkeeng Treatment Centre. Charles also worked at Winnipeg Child and Family Services for approximately three years. Charles then returned to school at the Winnipeg Education Centre, completing two years of the four year Bachelor of Social Work Program. Charles plans on returning to school to complete the Bachelor of Social Work Program at a later date.
